**FULL CYCLE GAME ACADEMY RELOCATION
GUIDE FOR NON-EU CITIZENS WHO NEED A D-VISA
BEFORE ENTERING ESTONIA**

Before relocating

1. School admission documents

School admission documents are given to every student who is accepted into Full Cycle Game Academy. These documents are one way to prove your travel purpose when applying for a D-visa. The documents are sent by Full Cycle Game Academy. Please request one from fullcycle@gamecan.eu.

2. Invitation by Full Cycle Game Academy

Invitation by Full Cycle Game Academy is another form of proof of travel when applying for D-visa. This document has all the information about your travel and the academy and is needed for students who are coming from outside Europe. The documents are sent by Full Cycle Game Academy. Please request one from fullcycle@gamecan.eu.

3. Applying for D-visa

Book an appointment at an Estonian Embassy closest to you.

When applying for D-visa, you need:

- **travel document** which is issued within previous 10 years, contains at least two blank pages for visas and is valid at least 3 months after the expiration date of the visa;
- fully completed and hand signed [application form](#);
- **photo** (size 35x45 mm);
- valid **health insurance** policy covering expenses due to illness or injury during the period of validity of the visa, in case of a multiple entry visa until the end of the first intended period of stay;
- documents indicating the [purpose of the journey](#): documents proving that the applicant is going to study in Estonia. During the examination of an application, a consular officer may request additional documents. When applying for a D-visa to study at Full Cycle Game Academy, please tick the option “**other**” and as an indication copy this text: “**I have an official**

invitation to take part of the advanced training course
Game Academy by Gamecan OÜ”;

- proof of **financial means**. Applicant must prove that he or she has sufficient financial means [according to the purpose of stay](#);
- at the time of submission of the application, **biometrical data** – 10 fingerprints of the applicant is collected; children under the age of 12 and persons for whom fingerprinting is physically impossible shall be exempt from the requirement to give fingerprints;
- **visa fee** EUR 100.
